Biometrics : Applicants who file Form N-400 and later appear at an application support center (ASC) for biometric capturing are required to submit to a photograph and signature process.

Application for Naturalization | USCIS

If you file your Form N-565 online, you may pay your fee online. If you file your Form N-565 by mail (paper), you may pay the fee with a money order, personal check, cashier's check, or by credit card using Form G-1450, Authorization for Credit Card Transactions. If you pay by check, you must make your check payable to the U.S. Department of Homeland Security.

The forms in this section are specifically related to U.S. citizenship and naturalization. Whether you are a legal permanent resident seeking to naturalize, or a U.S. citizen who is seeking proof of citizenship, USCIS forms beginning with "N-" are the forms you will need. Use the table below to find the form you need.

US Citizenship Forms - Application Forms Free Download

Submit your original evidence of U.S. citizenship. Submit a photocopy of the front (and back, if there is printed information) of your original evidence of U.S. citizenship. Photocopies must be: legible, on white 8.5"x11" standard paper, black and white, and single sided.

Citizenship Evidence - United States Department of State

Forms and Fees To apply for naturalization, you will need to submit Form N-400, Application for Naturalization. If you file your Form N-400 online, you may pay your fee online. Fees can change, so be sure to check with USCIS for the current fees before you submit your application.

You are a U.S. citizen if: You have a birth certificate issued by a U.S. state. You were born in a U.S. territory and have a birth certificate issued by that territory. If you don't have a birth certificate from your birth territory, you may be able to verify your citizenship status using other documents.

In general, naturalization was a two-step process* that took a minimum of five years. After residing in the United States for two years, an alien could file a "declaration of intention" ("first papers") to become a citizen. After three additional years, the alien could "petition for naturalization" ("second papers").

Naturalization Records | National Archives

As part of the naturalization process, all U.S. citizenship applicants are required to provide supporting documents to U.S. Citizenship and Immigration Services (USCIS). Which documents are necessary depends on each applicant's situation.

Documents Needed for the Citizenship Application and Interview

Documents serving as primary evidence of U.S. citizenship are: Birth Certificate or certified copy of Birth Certificate issued by a U.S. State or by the U.S. Department of State (for persons born abroad to U.S. citizen parents who registered the child's birth and U.S. citizenship with the U.S. Embassy or consulate);

Proof of Citizenship You must provide proof of citizenship for all US passport services. Most passport applicants are able to submit preferred evidence of United States citizenship for passport requests, such as a birth certificate showing birth in the United States or a previously-issued US passport.

U.S. naturalization records document the process whereby an individual born in another country (an "alien") is granted citizenship in the United States. Although the details and requirements have changed over the years, the naturalization process generally consists of three major steps: 1) the

Spouse. If you are a U.S. citizen you have two ways to bring your foreign spouse (husband or wife) to the United States to live. They are: Immigrant visa for a Spouse of a U.S. Citizen (IR1 or CR1) - An immigrant Petition for Alien Relative, Form I-130 is required. Learn more.
